



PPCU Scholarship Program - 2019 Eligibility, Application Requirements and Policies

Eligibility

To be eligible, students must meet the following criteria:

- **The Applicant must be a PPCU Member in good standing.** To become a PPCU member, complete and submit a Membership form which is available online at www.ppcu.org or at any branch.
- Must be a 2019 graduating high school senior who will be enrolled in an accredited 2- or 4-year college or vocational/trade school for the Fall of 2019 **OR**
- A current college or vocational school student who will continue schooling towards a degree in an accredited 2- or 4-year college or vocational/trade school for the Fall of 2019
- Have a minimum cumulative GPA of 2.50
- Must not have won a PPCU Scholarship in previous years
- PPCU Employees and Members of the PPCU Board of Directors and Supervisory Committee are not eligible

Application Requirements

Applicants must submit a **Completed Scholarship Application Form** and provide the information and documents stated on the application. **See Scholarship Application for details.**

Amount of Scholarships

PPCU will award five scholarships of \$1,000 each to chosen recipients.

Deadline and Policies

Completed application and required materials must be received by our main office at the following address before close of business April 1, 2019 or if mailed, postmarked by April 1, 2019, to be considered. 3. **Honors and Awards (during last 2 years):** For each award/honor, provide: Sponsor of the Award, Date received, and Why you won the award.

4. **Essay:** 500 words on the following: *“What banking features and services do you want your credit union to provide and why?”*

5. **Latest Official sealed High school or College Transcript** showing Cumulative GPA (**must be at least 2.50**).

6. **If you are a Graduating High School Senior:** Provide official correspondence showing acceptance to an accredited college or vocational school for the upcoming school year.

If you are a Current College Student: Provide official documents showing registered classes for the current term.
